1. My name is Norman Malinski and I have been admitted to practice pro hac vice to represent the persons or companies whose identities are being sought in this matter.


2. I can confirm to the Court that, at this time, I represent a total of 23 of the 29 persons or companies whose identities are being sought in this matter.


